PARTNERSHIP **SPOTLIGHTS**

Moody AFB Scores "Hole in One" with First of its Kind IGSA for Golf Course Operation

n March 30, 2023, leadership from Moody AFB and Lowndes County, GA signed an Intergovernmental Support Agreement (IGSA) under which Lowndes County would operate and maintain Moody's Quiet Pines Golf Course. The term of the agreement is for 10 years.

Quiet Pines Golf Course was established in 1968 and is located across the highway from Moody's primary perimeter fence line but still on installation property. Moody decided to close the course due to financial difficulties and had submitted a closure package to HAF. The idea for Lowndes County to take over operation originated during a casual conversation between Moody's Commander, Colonel Russ Cook, and the County Manager, Mrs. Paige Dukes. Lowndes County desired to support the base, and to provide affordable recreational opportunities to airmen, retirees, and community members, as well as provide a recreation venue to the public for the north end of county and surrounding communities and offered to take over operation of the course. The IGSA effort took off from there and was completed in less than one year's time. The County retained most of the course staff, and over time plans to hire a golf pro and to make upgrades to the course, driving range and pro shop.

Mr. Bill Slaughter, Chair of the County Board of Commissioners, fully supported



the agreement, viewing it as a new opportunity for partnership with Moody. The new initiative supports the base and adds a quality of life improvement for all of Lowndes County.

This IGSA is an excellent—and potentially replicable—example of an installation partnering with their community to solve a real challenge and improve the quality of life for people on and off the base. Both parties will benefit from this partnership, and it is certain to boost an already strong relationship.

Ebbing Field Air National Guard Base Uses IGSA to Prepare for New Mission

n March 2023, Ebbing Field Air National Guard Base (ANGB) in Fort Smith, AR was selected by the Department of the Air Force (DAF) to be the new host of the Foreign Military Sales Program Pilot Training Center. The Center will provide F-16 and F-35 training for multiple international partner nations. In addition, Ebbing Field will also be designated as an aircraft safety divert location for military aircraft operating in the region.

These important mission changes necessitate a variety of airfield improvements like a retractable Aircraft Arresting System (known as a BAK-14), as well as Arm/De-Arm pads for inert weapon loading and removal, and safety berms. The DAF and installation, facing tight budgetary and schedule requirements, decided to leverage 10 USC 2679 intergovernmental support agreement (IGSA) authority to implement an agreement with the Fort Smith Airport Commission that quickly and efficiently delivers these airfield safety services.

The Fort Smith Airport Commission eagerly supports the effort and views the agreement as beneficial to the airport, which still hosts commercial activity, and to Ebbing Field ANGB. The new mission bed-down is seen a "gamechanger" for the Fort Smith area and is expected to boost economic development in the region. Notably, it is also a gamechanger in terms of using the IGSA authority for rapid acquisition of services in times when mission needs call for swift and reliable action.



Air Force Mission Sustainment

The Mission Sustainment Program supports the DAF in identifying and assessing hazards that include actual or potential conditions that degrade. or potentially degrade, military testing, training, or other operational capabilities. Our team oversees and manages of the Mission Sustainment Risk Report (MSRR) process to assist in the identification of mission sustainment hazards at the installation level and elevate those risks through MAJCOMs to the HAF/SAF level Mission Sustainment Working Groups. Another tenet of the Mission Sustainment Program is to promote compatible development with renewable energy and industry developers, including coordination with the DOD siting Clearinghouse. Our team supports mitigation response to energy projects that have an impact to Air Force missions. Mitigations may include alterations to the siting of projects or turbines, changes to mission requirements or operating areas, curtailment, adjusting project timelines, etc. We also coordinate with the Federal Aviation Administration (FAA) Obstruction Evaluation/Airport Airspace Analysis (OE/AAA) system to perform the initial analysis of projects and distribute requests for project reviews by installations, airfield managers, MAJCOMs, and other stakeholders with Air Force equities. ADC Connect: Foreign Investment Near Military Installations and the Role of Defense Communities

On 22 June 23, Ms. Fisher and the Mission Sustainment Team attended an Association of Defense Connect Forum in Washington D.C. focused on concerns regarding foreign investments near military installations and the potential national security threat that these investments pose. The event shed light on important issues that impact the Air Force on a daily basis. The services and other federal agencies are currently ramping up to confront foreign adversary investment in defense communities. This forum allowed communities to share their experiences with this issue and begin to define the common challenges from the defense community and installation perspective. The issue of foreign investment adjacent to military installations can be highly complex and has become an emerging issue that DAF is facing.

Mrs. Sharene Brown Continues Her Inspiring Work with Five and Thrive

rs. Sharene Brown launched the Five & Thrive initiative in 2021. Her main goal is to improve the quality of life for Air Force families by focusing on 5 key areas: Childcare, Education, Healthcare, Housing, and Spousal Employment. As the spouse of the 22nd Chief of Staff of the Air Force, Mrs. Brown dedicated her time to finding innovative ways to connect spouses with the comprehensive resources they need at all phases of life. Mrs. Brown promoted the Air Force Community Partnership Program (AFCP) as a framework through which installation and community leaders can leverage capabilities to enhance mission performance, reduce costs, and improve quality of life. Several of these partnerships directly support family readiness such as the Tyndall AFB Spousal Employment Program. Through this partnership between Tyndall AFB, Gulf Coast State College, CareerSource

Gulf Coast, and Bay County Chamber of Commerce, Tyndall AFB spouses are given access to training, education, and/ or employment. An additional benefit to the partnership is a cost reduction of approximately \$200 a month, which provides the families with access to more affordable childcare. The community benefits by gaining access to a valuable workforce.

In March 2023 Mrs. Brown was recognized by the Association of Defense Communities (ADC) and Navy Federal Credit Union as the first recipient of the National Impact Award. She was honored for her dedication and contributions to defense communities across the nation. SAF/IEI - AFIMSC Charter Signed

Leadership from the Office of the Deputy Assistant Secretary of Air Force – Installations (SAF/IEI) and the Air Force Installation and Mission Support Center (AFIMSC) have signed a charter that "establishes a formal, coordinated relationship between SAF/ IEI and AFIMSC for the purpose of improving Department of Air Force (DAF) governance of community partnerships, providing clarity of mission, and enhancing direct support to installations." The charter formally integrates IMSC into the AF Community Partnership (AFCP) Program clarifying responsibilities between SAF (policy and governance) and AFIMSC (execution). The charter will be reviewed, and appropriate adjustments made, on an annual basis.
