### JOHN S. CRUMBLEY

John S. Crumbley, a Certified Safety Professional, is the Director of Safety Policy & Programs, contributing executive leadership and technical expertise to the Deputy Assistant Secretary of the Air Force for Environment, Safety, and Infrastructure. John is responsible for enterprise-wide policy, oversight, budgeting, systems development, and integration of Air Force safety programs affecting military, civilian, and contractor personnel employed by the Air Force or working on other DOD installations.

Prior to assuming his current position, he served as the Director of Occupational Safety & Health for the Naval Facilities Engineering Systems Command (NAVFAC), where he was responsible for policy, strategy, governance, and administrative oversight of safety programs at over 100 points of product and service delivery worldwide. He led efforts to develop plans and policies that ensured employee protection and readiness so that products and service were delivered safely and on time. In addition to NAVFAC, John also held other senior positions where he administered safety programs for Navy Region EURAFCENT and the Transportation Security Administration.



Prior to becoming a Civil Servant, John served as an enlisted member in the Air Force. His last assignment was HQ Air Force Global Strike Command where he was by-name selected to serve as the Non-commissioned Officer In-charge (NCOIC) of Safety. Along with several stateside and overseas assignments, John has also deployed to Prince Sultan Air Base in support of Operation Southern Watch. After 12 years of active duty service, he separated, became a Civil Servant, and retired from the AF Reserves with 21 years of total military service.
